



Terms and Conditions for the Social Media Landscaping Garden Glow-up Competition 2023:

By entering the 'Garden Glow Up 2023' Social Media Competition you accept and agree to be bound by the following terms and conditions:

- **Eligibility:** This competition is open to residents of the United Kingdom. Employees of the organizing company and their immediate family members are not eligible to participate. Please note, if you are entering as a tradesperson with pictures of your work, you will need written consent from the homeowner. By entering this competition, you agree to being contacted by MKM to confirm which branch you purchased the materials from and the approximate date of purchase.
- **Entry Method:** To enter, participants must share a photo showcasing their garden makeovers that include MKM Products (Instagram) tagging the respective MKM account in the caption. Only one entry per participant is allowed.
- All entries must comply with social media platform's terms of service to consist of a valid entry.
- All entries must obtain relevant permissions from any individuals appearing in video.
- **Ownership and Permissions:** By submitting an entry, participants grant the organizing company a non-exclusive, worldwide, royalty-free license to use, reproduce, publish, and display the images for promotional purposes.
- **Competition Period:** The competition will begin on Friday 11th August at 09:00 and will end on Monday 4th September at 09:00. Entries submitted outside of this period will not be considered.
- **Prize Details:** The winner will receive £500 in cash. If you are selected as the winner, you will be asked to participate in photography of your garden to feature in our upcoming landscaping brochure.
- **Winner Selection:** The winners will be selected by a panel of judges appointed by the organizing company. The entries will be judged based on the best use of MKM products in the garden and creativity. The decision of the judges will be final and no correspondence will be entered into.
- **Winner Notification:** The winner will be notified via direct message on the social media platform they used to enter the competition within seven (7) days of the competition closing date. If a winner does not respond within seven (7) days, the organizing company reserves the right to select an alternate winner.
- **Prize Delivery:** The prizes will be confirmed to the winners within thirty (30) days of confirming their details and eligibility. The organizing company is not responsible for any delays or damages that occur during delivery.
- **Prizes:** Prizes are allocated on a per entry basis. One entry is only eligible for one prize per individual. Group submissions are eligible as one entry for a single prize.
- **Publicity:** By accepting a prize, winners agree to participate in any reasonable publicity related to the competition, including but not limited to the use of their name, photograph, and video content in promotional materials.



- **Disqualification:** The organizing company reserves the right to disqualify any participant who violates the terms and conditions or engages in fraudulent or inappropriate behaviour.
- **Limitation of Liability:** The organizing company, its affiliates, and its agents will not be responsible for any loss, damage, or injury resulting from participation in the competition or acceptance and use of the prizes.
- **Modification or Termination:** The organizing company reserves the right to modify, suspend, or terminate the competition at any time without prior notice or liability.
